Circular No. BPS/21-22/13 FEE PAYMENT, REMINDER-2



Dear Parent,

It is with reference to previous circulars **Ref. No. BPS/21-22/05 & BPS/21-22/07 dated 16.04.2021 and 24.04.2021 respectively** wherein we had been requesting you to register your ward and to clear the fee dues of current Academic Session 2021-22.

It would be pertinent to mention here that even during such unprecedented time, our teachers and other staff members are putting their best efforts to imbibe quality education and are making the Teaching Learning process more disciplined, effective and joyful to the children of our society.

However, this is possible only with the cooperation of the parents, who are clearing the outstanding Fee Dues of their wards on time, that the school is able to pay the monthly Salaries of its Staff. <u>WE ARE EXTREMELY</u> THANKFUL TO SUCH PARENTS.

Kindly note that <u>Hon'ble Delhi High Court has issued a direction regarding payment of Tuition Fee vide</u> its Order No. W.P.(C) 4011/2020 dated 08.07.2020, that where parents are in default for payment of <u>Tuition Fee, school is free to decline to provide ID & Password for online education facility to the students, unless a valid reason in writing, along with the proof, is communicated by the parent.</u>

To know the procedure and different modes through which the fee can be paid, kindly refer our previous Circular No. BPS/21-22/05 dated 16.04.2021 (<a href="http://banasthalipublicschool.com/uploaded/news/BPS\_2021-22\_05\_0nline\_Fee\_Payment\_Circular.pdf">http://banasthalipublicschool.com/uploaded/news/BPS\_2021-22\_05\_0nline\_Fee\_Payment\_Circular.pdf</a>). For the ease of parents, the school has provided the platform for Online Fee Payment, where you can pay through Credit Card / Debit Card / Net Banking/ UPI/ Wallet. However, those who don't have the option of Net Banking facility, can pay the fees of their wards, by dropping the Cheque / Demand Draft (DD) at the Drop Box placed at School Main Gate. Along with this, parent is supposed to make the entry in the register which is kept with the Security Guard. Do follow the precautionary measures needed during COVID-19.

In view of the above, parents are requested to pay the outstanding Fee Dues (FROM APRIL TO JUNE 2021) latest by 10<sup>th</sup> June 2021 (Thursday) failing which the school shall be compelled to take necessary and appropriate action in accordance with the prescribed rules of DSEA&R, 1973 and High Court Ruling. (IF PAID, KINDLY IGNORE)

Further, in future, you are requested to clear the Fee Dues of your ward latest by 10<sup>th</sup> of every month.
