Dear Parent,

You are hereby informed that Directorate of Education, Govt. Of NCT, Delhi vide its order No. F.DE.15(1196)/PSB/2022/1039-1043 dated 02.02.2023 has accepted the Proposal of Fee Hike of our school and has allowed to implement the increase of Fee by 15 % only w.e.f. 1st October, 2022. However, this circular is not applicable for E.W.S/D.G./C.W.S.N. category students.

Even the 15% hike in the Fee as ordered by DoE is not sufficient to meet the increased financial liabilities of the School.
